Practice profile

After a successful completion of his pupillage with Mr Valentine Yim, Mr Paul Leung, Mr Alan Ng, Mr Eugene Yim and Ms Amanda Li, Eddie joined our Chambers in 2016 and commenced his practice.

Eddie has a broad practice which covers all aspects of civil matters, including commercial litigation, bankruptcy and corporate insolvency matters, matrimonial disputes and personal injury claims (both PI & EC claims). Eddie is developing a broad criminal practice and has experience in handling cases involving offences such as sexual offences, criminal intimidation, theft, conspiracy to defraud, breach of conditions of stay and assault.

Eddie is also acting for the 2nd Applicant (led by Mr M.K. Wong S.C. and Ms Vivian Wong) as junior counsel in ***HKSAR v Ho NS & Anor*** (CACC 259/2018), a case concerning “*fei ding*” (飛丁).

Acting for the Plaintiff; obtained an O.14 judgment against one of the Defendants and resisted a striking-out application.

Choi Chi Wai t/a Olivia Chocolate Company v Hsiu Jui Hein (DCCJ 1175/2015)

Acting for the Plaintiff; a case concerning breach of tenancy agreement.

Liu Ke Mian Lorraine v De Xin Da Trading Co., Ltd (HCA 2352/2015)

Acting for the Plaintiff and varied the *Mareva* Injunction and obtained a Garnishee order absolute.

HKSAR v Li YP & Ors (CACC 425/2015) (led by Mr Lawrence Lok S.C., Mr Valentine Yim and Mr Paul Leung)

Acting for nine of the Applicants; applying leave to appeal against conviction and sentence from the Court of Appeal.

HKSAR v Chan SY (HCMA 298/2016)

Acting for the Appellant; a case concerning committing an act outraging public decency.

HKSAR v Leung ML (DCCC 52/2016) (with Ms Vivian Wong)

Acting for the 1st Defendant in a 28-day trial; the 1st Defendant was charged with 4 counts of fraud, 3 counts of theft and 1 count of doing acts tending and intended to prevent the course of public justice. The 1st Defendant was acquitted after trial.

HKSAR v Lui TS (WKCC 159/2017) (with Mr Paul Leung)

Acting for the Defendant; a case concerning having sexual intercourse with a mentally incapacitated person. The Defendant was acquitted after trial with costs to the Defendant.
